## **Collision Avoidance System**

✓ Gert Venter presented on the EDG collision Avoidance System.

The following questions and answers followed:

- ✓ Q: How is this system different than other systems. What is your cost for this?
  - A: No big difference from other systems but EDG is the OEM for this product.
- ✓ Q: What is the liability if the system fails?
  - A: The liability lies with the different parties. The risk assessment is drawn up by the specific mines and we fill in with that.
- ✓ Q: What are the advantages and disadvantages of this system?
  - A: The GPS accuracy is only accurate to one metre. This system has changed to RTS that is accurate to a mm.
- ✓ Q: Any consideration for underground operations where the operations are fully mechanized?
  - A: This is a surface mine project.
- ✓ Q: The radius detection in metres, how is it determined?
  - A: The distances are determined by the mine.
