## STANDARD TERMS AND CONDITIONS OF RFQ

- A submission submitted in response to this RFQ will constitute a binding offer which will remain binding and irrevocable for a period of **thirty (30) days** from the date of submission to the MHSC. Bidders may not modify their initial pricing offer whilst the RFQ validity period is still in force. **(RFQ Validity Period: 30 days from date of closure)**
- No service will be rendered, or goods delivered before an official MHSC Purchase Order has been issued to the awarded bidder.
- It is the responsibility of the bidder to ensure that its response reaches MHSC on or before the closing date and time of the RFQ.
- Bidders may not make any alterations or additions to the content of this bid document, except to comply with the instructions issued by the MHSC.
- There shall be no discussions with any enterprise until evaluation of the proposal has been complete.
- RFQ's received after closing time and date will be classified as **LATE** and will not be considered.
- With regards to pricing, where a bidder submits both a quote and SBD 3, should the total bid prices differ, or calculation errors be identified, the one indicated on the SBD 3 pricing schedule shall be considered the correct price.
- MHSC reserves the right to cancel this RFQ due to the following reasons:
  - a) Due to changed circumstances, there is no longer a need for the services specified in this RFQ.
  - b) Funds are no longer available to cover the total envisaged expenditure for the project.
  - c) No RFQ meets the required specifications.
  - d) There is a material irregularity in the RFQ process.
  - e) Bidder fails to deliver in accordance with the requirements of the RFQ. The MHSC reserves the right to terminate the contract/PO during the first week after work has commenced should the appointed service provider have misrepresented themselves and/or their product and will not be able to fulfil the requirements as contained in the contract.



## **TERMS OF REFERENCE/SCOPE OF WORK**

### **1.1 OVERVIEW**

The Mine Health and Safety Council is a national public entity (Schedule 3A) established in terms of the Mine Health and Safety Act, No 29 of 1996, as amended.

The entity comprises a tripartite board represented by State, Employer, and Labour members under chairmanship of the Chief Inspector of Mines. The MHSC is funded by public revenue and is accountable to Parliament.

The main task of the Council is to advise the Minister of Mineral Resources on occupational health and safety legislation and research outcomes focused on improving and promoting occupational health and safety in South African mines. The Council also oversees the activities of its committees; promotes a culture of health and safety in the mining industry; arranges a summit every two years to review the state of occupational health and safety at mines; and liaises with the Mining Qualifications Authority and any other statutory bodies about mining health and safety.

### **1.2 DETAILED SPECIFICATIONS/SCOPE OF WORK**

The MHSC seeks to appoint a suitably qualified service provider to undertake a legal, technical and regulatory review of the remaining applicable health and safety-related regulations made under the Minerals Act and still applicable within the current MHSA framework, and to develop a consolidated MHSA-aligned regulatory framework incorporating the migrated applicable Minerals Act regulatory provisions.

The review must identify regulatory overlaps, inconsistencies, obsolete provisions, duplication, gaps, and areas requiring amendment, repeal, amendment, revision, consolidation, or migration into the MHSA framework. The outcome of the project must be a legally and technically aligned



draft regulatory package suitable for consideration by the MHSC advisory structures, namely, the Mining Regulations Advisory Committee (MRAC) and Legal Drafting Committee (LDC).

The appointed service provider will be expected to:

- Conduct a legal and technical review of the remaining applicable health and safety-related regulations made under the Minerals Act and still applicable within the current MHSA framework to identify overlaps, inconsistencies, and duplications with existing MHSA regulations.
- Produce a consolidated regulatory rationalisation report detailing provisions recommended for repeal, amendment, revision, consolidation, retention, or migration into the MHSA framework.
- Produce a draft consolidated MHSA-aligned regulatory framework with supporting explanatory notes and justifications.

#### **1.1 Special Conditions: (if any)**

- All deliverables and milestone reports shall be subject to review and written approval by the MHSC prior to acceptance and progression to subsequent project phases.
- The service provider must be available to provide presentations to the MHSC's advisory committees, namely the Mining Regulations Advisory Committee (MRAC) and Legal Drafting Committee (LDC);
- The service provider must demonstrate prior experience with legislative and regulatory drafting, preferably within the mining, occupational health and safety, or public sector context.
- The service provider must showcase a strong working knowledge of the Mine Health and Safety Act.
- The team must include at least one qualified legal professional with expertise in legislative analysis and drafting.
- The service provider must complete all service-provider activities and deliverables within four (4) months of appointment.
- Bidders may submit proposals as a consortium or multidisciplinary team, provided that the combined team demonstrates the required legal, technical, mining and regulatory competencies.

- The service provider may be required to attend additional technical engagements and presentations with MHSC advisory structures as reasonably required during the project duration.

## **2. SCOPE OF WORK**

The service provider will be required to undertake the following as part of the scope of work:

- 2.1 Project Initiation – Contracting, inception planning and methodology for execution of the project.
- 2.2 Conduct a legal and technical review of the remaining applicable health and safety-related regulations made under the Minerals Act, including identification of overlaps, inconsistencies, obsolete provisions, duplication, and regulatory gaps within the current MHSA framework.
- 2.3 Undertake a regulatory mapping and gap analysis exercise between the remaining applicable Minerals Act regulatory provisions, existing MHSA regulations, and current mining industry practices to identify provisions requiring repeal, amendment, revision, consolidation, retention, or migration into the MHSA.
- 2.4 Develop a consolidated regulatory rationalisation framework outlining recommendations and justifications for:
  - 2.4.1 repeal of obsolete provisions;
  - 2.4.2 amendment or revision of existing provisions;
  - 2.4.3 migration of applicable residual Minerals Act regulatory provisions into the MHSA framework; and
  - 2.4.4 development of additional provisions where regulatory gaps are identified.
- 2.5 Conduct technical engagement sessions and presentations with relevant MHSC advisory structures, including the Mining Regulations Advisory Committee (MRAC) and Legal Drafting Committee (LDC), to solicit inputs on the proposed regulatory framework and recommendations.

- 
- 2.6 Prepare a draft consolidated MHSA-aligned regulatory package incorporating the migrated applicable Minerals Act regulatory provisions, together with supporting explanatory notes and justifications, suitable for submission to MRAC and LDC.

The service provider must ensure that all proposed migrated provisions are aligned with the structure, terminology and legislative framework of the Mine Health and Safety Act.

### **3. EXPECTED OUTCOMES**

- 3.1 Inception report detailing the methodology, project plan, timelines, and technical engagement approach.
- 3.2 Legal and technical review report on the remaining applicable health and safety-related Minerals Act regulatory provisions, including identified overlaps, inconsistencies, obsolete provisions, and regulatory gaps.
- 3.3 Regulatory mapping and gap analysis matrix indicating provisions recommended for repeal, amendment, revision, consolidation, retention, or migration into the MHSA framework.
- 3.4 Regulatory rationalisation report containing detailed recommendations and motivations for all proposed regulatory actions.
- 3.5 Technical engagement and consultation report summarising inputs received from MHSC advisory structures, key issues raised, and proposed resolutions.
- 3.6 Draft consolidated MHSA-aligned regulatory package incorporating migrated applicable Minerals Act regulatory provisions, including supporting explanatory notes and justifications.
- 3.7 Final revised consolidated MHSA-aligned regulatory framework incorporating migrated applicable Minerals Act regulatory provisions and comments from the MHSC, MRAC and LDC, including a comment-response matrix indicating how stakeholder comments were addressed.

### **1.3 CONTRACT PERIOD**

The contract will be valid for a period of 5 months.



#### 4. REQUIRED EXPERIENCE

- 4.1 Minimum of 10 years' experience in legislative or regulatory drafting, preferably within the mining, occupational health and safety, engineering, environmental, or public regulatory sectors.
- 4.2 Minimum of 10 years' experience in mining engineering, mine health and safety, mining operations, or mining regulatory implementation.
- 4.3 Demonstrated experience in mining legislation, subordinate legislation, regulatory reform, or statutory interpretation within the South African mining sector will be advantageous.

**Note:** In instances whereby team members resign or become unavailable during the project duration, bidders must ensure that replacement resources possess the required qualifications and experience, subject to approval by the MHSC.
