STANDARD TERMS AND CONDITIONS OF RFQ

- A submission submitted in response to this RFQ will constitute a binding offer which will remain binding and irrevocable for a period of **thirty (30) days** from the date of submission to the MHSC. Bidders may not modify their initial pricing offer whilst the RFQ validity period is still in force. **(RFQ Validity Period: 30 days from date of closure)**
- No service will be rendered, or goods delivered before an official MHSC Purchase Order has been issued to the awarded bidder.
- It is the responsibility of the bidder to ensure that its response reaches MHSC on or before the closing date and time of the RFQ.
- Bidders may not make any alterations or additions to the content of this bid document, except to comply with the instructions issued by the MHSC.
- There shall be no discussions with any enterprise until evaluation of the proposal has been complete.
- RFQ's received after closing time and date will be classified as **LATE** and will not be considered.
- With regards to pricing, where a bidder submits both a quote and SBD 3, should the total bid prices differ, or calculation errors be identified, the one indicated on the SBD 3 pricing schedule shall be considered the correct price.
- MHSC reserves the right to cancel this RFQ due to the following reasons:
 - a) Due to changed circumstances, there is no longer a need for the services specified in this RFQ.
 - b) Funds are no longer available to cover the total envisaged expenditure for the project.
 - c) No RFQ meets the required specifications.
 - d) There is a material irregularity in the RFQ process.
 - e) Bidder fails to deliver in accordance with the requirements of the RFQ. The MHSC reserves the right to terminate the contract/PO during the first week after work has commenced should the appointed service provider have misrepresented themselves and/or their product and will not be able to fulfil the requirements as contained in the contract.



TERMS OF REFERENCE/SCOPE OF WORK

1.1. OVERVIEW

The Mine Health and Safety Council is a national public entity (Schedule 3A) established in terms of the Mine Health and Safety Act, No 29 of 1996, as amended. The entity comprises a tripartite board represented by State, Employer, and Labour members under chairmanship of the Chief Inspector of Mines. The MHSC is funded by public revenue and is accountable to Parliament. The main task of the Council is to advise the Minister of Mineral Resources on occupational health and safety legislation and research outcomes focused on improving and promoting occupational health and safety in South African mines. The Council also oversees the activities of its committees; promotes a culture of health and safety in the mining industry; arranges a summit every two years to review the state of occupational health and safety at mines; and liaises with the Mining Qualifications Authority and any other statutory bodies about mining health and safety.

1.2. DESCRIPTION

The Mine Health and Safety Council (MHSC) invites suitably qualified, competent and experienced service providers to render professional cleaning, hygiene and fumigation services at its offices for a period of twenty-four (24) months. The objective of this appointment is to maintain a clean, hygienic, safe and conducive working environment for employees, stakeholders and visitors.

1.3. DETAILED SPECIFICATIONS/SCOPE OF WORK

The service provider will be required to undertake the following as part of the scope of work:

1.3.1. General Cleaning Services

- Sweeping, vacuuming and mopping of all floor surfaces;
- Dusting and cleaning of desks, furniture, shelving, office equipment and windowsills;
- Cleaning and polishing of glass partitions, mirrors, internal doors and entrance doors;
- Cleaning of reception areas, boardrooms, meeting rooms, offices, passages and staircases;
- Cleaning and sanitising of kitchens, canteens and pause areas;

- Cleaning, disinfecting and deodorising of ablution facilities;
- Emptying of refuse bins and replacing refuse bags;
- Collection and disposal of waste in designated refuse areas;
- Spot cleaning of walls, doors and light switches;
- Removal of cobwebs;
- Daily replenishment of hygiene consumables supplied by MHSC or the service provider, as applicable.

1.3.2. **Hygiene Services**

- Servicing of sanitary bins;
- Cleaning and disinfecting of sanitary disposal units;
- Cleaning and sanitising of washrooms;
- Maintaining high hygiene standards in accordance with Occupational Health and Safety requirements.

1.3.3. **Human Resources Requirements**

The service provider shall provide a total of four (4) cleaning personnel, comprising:

Two (2) male cleaners; and

Two (2) female cleaners.

One (1) of the four cleaning personnel shall be designated as the Site Supervisor.

The Site Supervisor shall perform both supervisory duties and cleaning duties as required, while remaining responsible for the day-to-day coordination and quality control of the cleaning services. The Site Supervisor shall be available during normal working hours and shall be contactable after hours for emergencies. The male cleaners shall, in addition to their cleaning responsibilities, provide general handyman support related to routine facilities maintenance. Such duties may include, but are not limited to:

- Moving office furniture and equipment;
- Replacing light bulbs where safe to do so;
- Hanging notice boards, picture frames and signage;
- Minor repairs such as tightening loose fittings, door handles and cabinet hardware;

- 
- Assisting with office relocations and setting up boardrooms;
 - Loading and unloading office supplies and deliveries;
 - Reporting maintenance defects requiring specialised repairs to the MHSC Facilities Management Officer.

All personnel shall:

- Be adequately trained and supervised;
- Be medically fit to perform their duties;
- Always wear appropriate uniforms and visible identification;
- Conduct themselves professionally while on MHSC premises;
- Comply with all Occupational Health and Safety requirements, including the use of appropriate Personal Protective Equipment (PPE);
- Be vetted where required by MHSC security procedures.

The Contractor shall immediately replace any employee whose conduct or performance is deemed unsatisfactory by MHSC.

1.3.4. Cleaning Equipment and Materials

The Contractor shall provide:

- Vacuum cleaners;
- Floor polishers;
- Mops and buckets;
- Warning signage;
- Cleaning cloths;
- Brooms;
- Refuse bags;
- Cleaning chemicals;
- Personal Protective Equipment (PPE).

All disinfectants shall be those that are SABS/SANS approved.



1.3.5. **Emergency Hygiene Support**

The Contractor shall provide portable toilet facilities on an "*as and when required*" basis during:

- Water outages;
- Planned maintenance;
- Emergency incidents;
- Building shutdowns.

The Contractor shall:

- Deliver and install portable toilets within agreed response times;
- Service and clean the units regularly;
- Remove waste in accordance with environmental legislation;
- Supply consumables;
- Remove unit's once normal services resume.

Additional costs shall only be incurred after written approval by MHSC.

1.3.6. **Additional Cleaning Personnel**

The Contractor shall provide additional cleaning personnel when requested by MHSC during:

- Conferences;
- Workshops;
- Audits;
- VIP visits;
- Disease outbreaks;
- Water interruptions;
- Emergency incidents.

Personnel shall be deployed within agreed response times



1.3.7. **Fumigation and Pest Control**

Quarterly fumigation shall be undertaken and shall include:

- Rodent control;
- Cockroach treatment;
- Ant control;
- Mosquito control;
- Fly control;
- Spider treatment;
- General crawling insect treatment.

The Contractor shall:

- Conduct inspections before treatment;
- Use approved pesticides;
- Display warning notices;
- Submit treatment certificates;
- Submit recommendations to prevent future infestations.

1.3.8. **Quality Assurance**

The Contractor shall ensure that:

- All services comply with acceptable industry standards;
- Work is inspected daily by the Site Supervisor;
- Deficiencies identified by MHSC are rectified within 24 hours;
- Staff attendance registers are maintained.

1.3.9. **Reporting**

The Contractor shall submit:

- Monthly cleaning reports;
- Monthly attendance registers;
- Quarterly fumigation reports;
- Incident reports;

- Monthly service schedules.

1.3.10. WORKING HOURS

Normal Working Hours	The Contractor shall provide routine cleaning services Monday to Friday, from 07h00 to 16h00, excluding public holidays, unless otherwise instructed by the MHSC.

After-Hours Services	The Contractor may be required to render cleaning services outside normal working hours for, inter alia: ➤ Executive meetings; ➤ Workshops; ➤ Special events; and ➤ Emergency situations.

After-hours services shall only be rendered upon receipt of a prior written instruction / purchase order from the MHSC duly authorized representative.

1.4. CONTRACT PERIOD

The contract period shall be twenty-four (24) months with effect from the effective date. Notwithstanding anything to the contrary, the contract shall be subject to satisfactory performance by the Service Provider, continued budget availability, and annual performance assessment, failing which the MHSC reserves the right to terminate the contract upon giving reasonable notice.

RFQ EVALUATION PROCESS

SCM COMPLIANCE REQUIREMENTS (RETURNABLE DOCUMENTS)

The RFQ will be evaluated in various phases as mentioned below:

- a) **Phase 1:** SCM compliance requirements (returnable documents).
- b) **Phase 2:** Functionality evaluation.
- c) **Phase 3:** Price and Specific Goals evaluation.

Phase 1: SCM Compliance requirements (Returnable documents)

RFQs received will be verified for completeness and correctness. MHSC reserve the right to accept or reject an RFQ based on the completeness and correctness of the documentation and information provided.

No award will be done without complete provision of returnable documents and any schedules.

Specific goals

Bid price proposals are compared on an equal and fair basis, considering all aspects of the bid pricing requirements. Qualifying bids are ranked on price and specific goals points claimed in the following manner:

- (i) **Price** - with the lowest priced bid receiving the highest price score as set out in the Preferential Procurement Regulations 2022.
- (ii) **Preference** - preference points are allocated in accordance with the Preferential Procurement Policy Framework Act (Act 5 of 2000) and its Regulations 2022 as claimed in the specific goals claim form (SBD 6.1) are added to the price ranking scores. The points for specific goals must be supported by a valid B-BBEE certificate or certified sworn affidavit.

A maximum of 80 points will be allocated for price on the following basis: **80/20**

The award of this RFQ may be subject to price negotiations where there are opportunities where prices are not market related. Under no circumstances will negotiation with any Bidders, constitute an award or promise/ undertaking to award the contract.

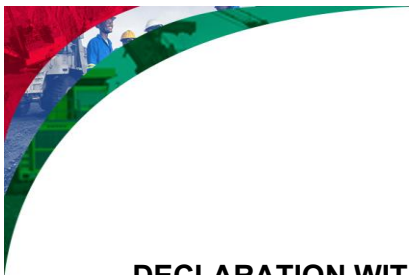
